The People of the State of Illinois,
To the Sheriff or Bailor of Morgan County - Greeting.

Whereas a petition has been presented to the
Supreme Court by Joseph Popper alleging that
he the said Joseph Popper is confined in your
custody upon a criminal charge, and praying
the benefit of the People's writ of Habeas Corpus,
in order that he may be released from custody,
upon which an order has been made requiring
the issuing of the said writ, and directing that
the said writ be made returnable before the
said Supreme Court of the State of Illinois
now in session, all which appears from the
petition aforesaid and order in that behalf.

Wherefore we command you that you do
cause the said Joseph Popper to be brought
before the said Supreme Court of the said
State of Illinois without delay (together with
an account of the causes of his being taken
and detained in custody) to perform and
abide such order as the said Supreme
Court shall make in the premises, and
that you also return this writ to the said
Court, and hereof fail not, under the
penalty of the law.
