December A.D. 1858.

Be it remembered that on the Seventeenth day
of December A.D. 1858 in the aforesaid term of said Court
the following order and judgment was made
and entered in said Court in a certain cause therein
pending wherein Henry Stevens was plaintiff
and David Reed, Adam Ziegler, Samuel Bruner
were defendants to wit —

David Reed

Adam Ziegler &

Samuel Bruner

vs

Assumpsit

This day came the Parties by their
attorneys and view being joined came a jury trial. —
Charles McOsborn, George W Nefflin, David Benson,
William Leaddwell, Roy Deros, Henry Lascelle, C^W Jennings.

D N Wells. A. LeSueur. J N Huber. A. J. Webster. and John B Phillips who are each and severally sworn to tell and truly try the issue joined and having heard the evidence returned their verdict into Court which is as follows viz: we the jury find for the Plaintiff and assess his damages at the sum of Three Hundred & fifty six Dollars and forty cents. It is thereupon ordered by the Court that Plaintiff have and recover of Defendants the said sum of Three hundred & fifty six dollars and forty cents together with Costs of suit and that he have execution therefor. Thereupon the defendants pray an appeal to the Supreme Court which is allowed upon the Condition they enter into bond in the sum of Six hundred and fifty dollars with George C Holmes. and Miles Nicholson as security which said bond shall be filed in the Circuit Clerk's office by the first of March next.

And afterwards and on the twenty second day of February A.D. 1859 the said defendants caused to be filed in the Clerk's Office of said Court their bond on appeal in the above Cause which is in the words and figures following to wit:—

Know all men by these presents that we David Reed. Adam Yegler. Samuel Bunker Miles Nicholson & George C Holmes are held and firmly bound unto Henry Stevens in the penal sum of Six hundred and fifty dollars lawful money

of the United States. to the payment of which well
and truly to be made we hereby bind ourselves. our
heirs Executors & administrators jointly severally and
family by these presents. Sealed with our seals and
dated this 21st day of December in the year of
our Lord one thousand eight Hundred and fifty
eight.

The Condition of the above obligation is such
that whereas the above named Henry Stevens did on
the 17th day of December A.D. 1858. in the Circuit
Court of the County of Rock Island in the State
of Illinois at the December Term thereof recover
Judgment against the said David Reed Adam Ziegler
& Samuel Brunner in the sum of Three Hundred
Fifty six & 4/100 Dollars damages with Costs of suit in
an action in which said Henry Stevens is plaintiff
and David Reed Adam Ziegler one Andrew J Brown
Not served and Samuel Brunner are defendants and
whereas the said David Reed Adam Ziegler & Samuel
Brunner have prayed an Appeal from the judgment
of the Circuit Court of the County of Rock Island
aforesaid to the Supreme Court of the State of
Illinois which has been allowed. Now if the said
David Reed Adam Ziegler and Samuel Brunner
shall well and truly pay the full amount of said
judgment together with all interest which may
accrue upon the same and the Costs of said suit
and all the Costs of said Appeal together with all

damages. And shall duly prosecute their said Appeal. then this obligation shall be null and void otherwise in full force and effect.
