fully considered the motion and the testimony
in this case. It is hereby ordered and
adjudged that the Plaintiff recover of
said Defendant the sum of Three Hundred
and Fifty one Dollars and fifty cents
(\$351.50) the amount collected by said
Defendant on the execution referred to
in motion, after deduction cost retained
by defendant for use of himself and the
other officers of this Court also the sum
of Thirty Five Dollars and Sixty
cents damages allowed by the Statute

"and it is further considered by the Court
" that the Plaintiff recovers of the Defendant
" his costs herein expended
" and that Execution is issued therefor
"

" This day upon motions of the
" ~~Defendants~~ ^{Plaintiff} leave is granted him by
" the Court to file appeal Bond in 20 days
" with Benjamin S. Peltzman as security.

And now afterwards, to wit, on the
second day of May in the year last
appears the Defendant files their appeal
Bond in the words and figures following
to wit:

" We all men by these presents that We
" Thomas C. Reeves and Benjamin S. Peltzman
" are held and firmly bound unto William
" Thomas Trustee of the Bank of Illinois
" in the penal sum of eight hundred dollars
" (\$800) current money of the United States for
" the payment of which well and truly to be
" made We hereby bind ourselves, our heirs
" executors and administrators severally jointly
" and firmly by these presents.
" Witness our hands and Seals this 2nd

1 day of May. A.D. 1837

2 The condition of the above
obligation is such that Whereas the said William
Thomas, Trustee as aforesaid did on the
8th day of April A.D. 1837 in the Circuit Court
of the County of Tazewell and State of Illinois
receive a judgment against the above bounden
J. C. Rives as late Sheriff of Tazewell County
for the Sum of Three hundred and fifty one
50/100 Dollars Debt and 35/100 Dollars Damages
and costs of Suit (\$95) from which judgment
of the Circuit Court, the said Thomas C. Rives
has prayed for and obtained an
Appeal to the Supreme Court of said
State. Now if the said Thomas C. Rives
shall duly prosecute his said Appeal with
effect, and shall moreover pay the
amount of the judgment costs and damages
rendered and to be rendered against
him in case the said judgment shall
be affirmed in the said Supreme Court
then the above obligations to be void otherwise
to remain in full force and
virtue
