our hands and Seals this 29th day of December
AD 1860.

The Condition of the above obligation is such

Mc Kittick did on the 10th of December AD 1860
recover a judgment before the Jackson County Circuit
Court State of Illinois, against the above bounden

of nine hundred and thirty five 00/100 dollars and
costs of Suit from which judgment the said
