The People of the State of Illinois,

To the Sheriff of the County of *Stephenson* Greeting:

BECAUSE in the record and proceedings, and also in the rendition of the judgment of a plea which was in the circuit court of *Stephenson* county, before the Judge thereof, between *John Lerch* complainant

& *Cyrus A. Shutz & Jared Shutz*

defendants, it is said that manifest error hath intervened, to the injury of the said *Lerch*

Shutz & Jared Shutz* notice, together with this writ.
